**DEBTOR'S CERTIFICATION OF COMPLETION OF INSTRUCTIONAL COURSE CONCERNING
PERSONAL FINANCIAL MANAGEMENT; DECLARATION OF ELIGIBILITY FOR CHAPTER 7 DISCHARGE**
